## **DATA PROTECTION POLICY**

In accordance with the General Data Protection Regulation that comes into force 25/5/18, Hereford Couriers Running Club require members' agreement to collect, keep and destroy certain information about them as described here.

The information in question will be name, date of birth, gender, email address, address, telephone number.

The Club may :
